1. The Government of Tamil Nadu through Government of India has applied for financing from the Asian Development Bank (ADB) toward the cost of Chennai Kanyakumari Industrial Corridor Project. Part of this financing will be used for payments under the Contracts named above. Bidding is open to eligible Bidders from eligible source countries of ADB. Bidders may bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Financial Bid.
2. The Chennai Kanyakumari Industrial Corridor Project, Highways and Minor Ports Department ("the Employer") for and on behalf of the Governor of State of Tamil Nadu invites sealed bids from eligible Bidders for the construction, maintenance and completion of **"Upgrading and Maintenance of Kumbakonam–Mannargudy Road (SH66) from Km 3/600 to Km 8/600 and from Km 13/900 to Km 23/800 to two lane with paved shoulders and maintenance of entire project stretch design length of 14.900 km for 7 years"**(in the State of Tamil Nadu on Engineering, Procurement and Construction (EPC) Mode)("the Works").
3. Open competitive bidding will be conducted in accordance with ADB's "Single-Stage: Two-Envelope" procedure and is open to all Bidders from eligible countries as described in the Bidding Document. The Bidder shall have
 - the nationality of an eligible country approved by ADB
 - Minimum average annual construction turnover of INR 132,00,00,000 (INR One Hundred and Thirty Two Crore Only) calculated as total certified payments received for contracts in progress or completed within last 5 years.
 - Participation in atleast one contract with a value of at INR 70 Crore only (INR Seventy Crore Only) or two contracts with a value of at least INR 53 Crore only (INR Fifty Three Crore only) in each contract within last 5 years.
