
1. The Government of Tamil Nadu through Government of India has applied for financing from the Asian Development Bank (ADB) toward the cost of Chennai Kanyakumari Industrial Corridor Project. Part of this financing will be used for payments under the Contracts named above. Bidding is open to eligible Bidders from eligible source countries of ADB. Bidders may bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Financial Bid.
2. The Chennai Kanyakumari Industrial Corridor Project, Highways and Minor Ports Department ("the Employer") for and on behalf of the Governor of State of Tamil Nadu invites bids from eligible Bidders for the construction, maintenance and completion of "Upgrading of Tiruchendur – Palayamkottai – Ambasamudram Road (SH40-I) from Km 0/750 to km 25/600 and km 38/550 to km 51/310 including construction of bypass from km 25/600 to km 38/550 for a length of 12.95 km and maintenance of entire project stretch design length of 50.590 km for 7 years (in the State of Tamil Nadu on Engineering, Procurement and Construction (EPC) Mode), ("the Works").
3. Open competitive bidding will be conducted in accordance with ADB's "Single-Stage: Two-Envelope" procedure and is open to all Bidders from eligible countries as described in the Bidding Document. The Bidder shall have
 - the nationality of an eligible country approved by ADB
 - Minimum average annual construction turnover of INR 248,00,00,000 calculated as total certified payments received for contracts in progress or completed within last 5 years.
 - Participation in atleast one contract with a value of at INR 212 Crore only (INR Two Hundred and Twelve Crore Only) or two contracts with a value of at least INR 159 Crore only (INR One Hundred and Fifty Nine Crore only) in each contract within last 5 years.
