

1. The Government of Tamil Nadu through Government of India has applied for financing from the Asian Development Bank (ADB) toward the cost of Chennai Kanyakumari Industrial Corridor Project. Part of this financing will be used for payments under the Contracts named above. Bidding is open to eligible Bidders from eligible source countries of ADB. Bidders may bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Financial Bid.
2. The Chennai Kanyakumari Industrial Corridor Project, Highways and Minor Ports Department ("the Employer") for and on behalf of the Governor of State of Tamil Nadu invites sealed bids from eligible Bidders for the construction, maintenance and completion of **"Upgrading of Tiruchendur – Palayamkottai – Ambasamudram Road (SH40-II) from Km 64/200 to Km 85/700 including Construction of ROB with approach roads from Km 75/020 to Km 76/180 for a length of 1060 m and maintenance of entire project stretch design length of 21.400 km for 7 years** in the State of Tamil Nadu on Engineering, Procurement and Construction (EPC) Mode" ("the Works").
3. Open competitive bidding will be conducted in accordance with ADB's "Single-Stage: Two-Envelope" procedure and is open to all Bidders from eligible countries as described in the Bidding Document. The Bidder shall have
 - the nationality of an eligible country approved by ADB
 - Minimum average annual construction turnover of INR 145,00,00,000 (INR One Hundred and Forty Five Crore only) calculated as total certified payments received for contracts in progress or completed within last 5 years.
 - Participation in at least one contract with a value of at INR 99 Crore only (INR Ninety Nine crore Only) or two contracts with a value of at least INR 75 Crore only (INR Seventy Five crore only) in each contract within last 5 years.
