1. The Government of Tamil Nadu through Government of India has applied for financing from the Asian Development Bank (ADB) toward the cost of Chennai Kanyakumari Industrial Corridor Project. Part of this financing will be used for payments under the Contracts named above. Bidding is open to eligible Bidders from eligible source countries of ADB. Bidders may bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so provided those discounts are included in the Letter of Financial Bid.
2. The Chennai Kanyakumari Industrial Corridor Project, Highways and Minor Ports Department ("the Employer") for and on behalf of the Governor of State of Tamil Nadu invites sealed bids from eligible Bidders for the construction, maintenance and completion of "Upgrading Chengalpattu - Kanchipuram Road section of SH-58 from km 30.000 to km 49.114, km 52.400 to km 52.584 to four(4) lane with paved shoulders and km 52.584 to km 60.136 to two (2) lane with paved shoulders and construction of proposed 6.846 km Walajabad Bypass from km 49.114 to km 52.400 to four(4) lane with paved shoulders and upgrading Military Road from km 0.080 to km 6.301 to two lane with paved shoulders and maintenance of entire project stretch of 39.786 km for 7 years" (in the State of Tamil Nadu on Engineering, Procurement and Construction (EPC) Mode) ("the Works").
3. Open competitive bidding will be conducted in accordance with ADB's "Single-Stage: Two-Envelope" procedure and is open to all Bidders from eligible countries as described in the Bidding Document. The Bidder shall have
 - the nationality of an eligible country approved by ADB
 - Minimum average annual construction turnover of INR 365,00,00,000 (INR Three Hundred and Sixty Five Crore Only) calculated as total certified payments received for contracts in progress or completed within last 5 years.
 - Participated in atleast one contract with a value of at least INR 340 Crore only (INR Three Hundred and Forty Crore Only) or two contracts with a value of at least INR 255 Crore only (INR Two hundred and Fifty Five Crore only) in each contract within last 5 years.
